### Event Registration Policies

#### Agreement

These are the terms and conditions governing your participation in Sage's meeting, show, seminar, summit or conference (the "Event"). #### Event registration payment

Registration for Sage Partner Summit costs \$99 USD per attendee. The \$99 USD fee must be paid at the time of registration and must be paid using a credit card. Your registration entitles you to access and attend the Event for which you have registered. Any and all other costs associated with your attendance shall be borne solely by you and Sage shall have no liability for such costs.

#### Event registration confirmation

Registration for Sage Partner Summit will be confirmed by email when full payment is received. If you do not receive a confirmation within 48 hours after your completed registration and payment are submitted, please [email](#) the Sage team.

#### Event cancellation policy

Event cancellation requests must be submitted in writing and received on or before midnight ET May 12, 2021 to receive a refund, less a \$25 service and processing fee. Cancellation requests received after midnight ET May 12, 2021, and no-shows are not eligible for a refund.

Transfer of the registration fee to subsequent years is not permitted. Cancellation requests must be submitted in writing and sent to the [Sage Partner Summit](#) team. Sage reserves the right to refuse or cancel a registration at any time with no liability other than refunding the applicable registration fee. Registrants must be 21 years of age to register for the event.

#### Event substitution policy

Attendee substitutions from the same company may be made up to one week prior to the event (May 18, 2021). Transferring registration status to an individual outside your company is not permitted. Contact the [Sage Partner Summit](#) team to request a substitution

or a full cancellation. **Note:** The transfer process is not complete until the new attendee request is submitted, and the new attendee has registered.
