

Terms and Conditions

Event Date: June 7 – 10, 2022

These terms apply to your registration for the Sage Partner Summit.

Participant Terms and Conditions

These terms and conditions are a legally binding agreement between you and Sage Software, Inc. and govern your participation in Sage Partner Summit (the “Event”). By registering for the Event, you agree to these terms and conditions. If you are registering on behalf of another individual, it is your responsibility to ensure the person participating is aware of these terms and accepts them. By completing the registration on behalf of another individual, you are warranting that you have made the individual aware of these terms and that they have accepted these terms.

Event registration confirmation

Registration for Sage Partner Summit will be confirmed by email when a registration form is completed and submitted. If you do not receive a confirmation within 48 hours, please [email](#) the Sage team.

Registration Cancellation

Group registration purchases are final upon purchase. No pass changes or cancellations/refunds will be permitted after purchase.

For individual registration purchases, cancellation requests made by May 31, 2022 are eligible for a full refund, less a \$100 processing fee. Cancellation requests received after May 31, 2022 are not eligible for a refund. Transfer of the registration fee to subsequent years is not permitted. Cancellation requests must be submitted in writing to the [Sage Partner Summit team](#). If you are entitled to a refund, the amount refunded will be based on the fees paid for the registration(s) you cancel and will be refunded to your original payment method.

Canceling your registration does not automatically cancel your hotel and travel arrangements. You are responsible for your own hotel and travel related fees.

Substitution

Registration substitutions from the same company can be made without penalty up until the start of the event (June 7, 2022). Transferring registration to an individual outside your company is not permitted. Any registration substitution requests must be made in writing by contacting the [Sage Partner Summit team](#).

Admittance and Attendance Requirements

You must be at least twenty-one (21) years of age to attend the Event and any related events. Your registration access for the Event is personal to you and may not be shared with others.

Denial of Registration, Entry, or Participation

Sage reserves the right to deny registration or entry to any individual or entity for any reason, in Sage’s sole discretion, including for past or present failure to meet Sage standard of business conduct, false pretenses or engaging in any violent, illegal, threatening, libelous, indecent or discriminatory conduct.

Badges

Badges are to be picked up at the registration check-in area during the event. You must show a government-issued picture ID to be issued your badge. A badge will not be issued without a proper ID and you will not be admitted into the venue without a badge. Badges may contain RFID and/or NFC tags, which will be used to record your attendance and participation in the event and to provide you with feedback surveys following attended breakout sessions. If you demonstrate an interest in a partner or topic, such as by visiting a booth or attending a session, Sage may share your registration information. Information collected through badges will not be disclosed to any other third parties.

Personal information

By registering for the event, you agree that Sage may use your email address and mobile phone number to send event updates, post-event survey evaluations, and for purposes of sales follow ups. Additionally, by engaging with Sage partners and/or sponsors/exhibitors, you authorise Sage to share with such partner or sponsor/exhibitor your first and last name, title, company, physical address, phone numbers, and email address provided to Sage as registration information. If you enter your mobile phone number, you may receive event updates via your mobile phone (by voice, SMS, MMS, or otherwise) at your own cost.

- You hereby voluntarily, knowingly and freely accept and assume all such Inherent Risks related to COVID-19 or similar viruses, even if arising from the negligence or fault of the Released Parties (as defined below);
- In addition to these terms, you agree to abide by any Event Health and Safety Protocols, including all applicable health and safety laws, rules, regulations, and governmental recommendations.
- Your attendance and participation in the Event is completely voluntary with knowledge of the dangers involved;
- You agree to accept and assume all risks of injury, illness, disability, death and/or property damage arising from your participation in the event, whether caused by the negligence of Sage or otherwise.

Release of liability

Sage shall not be liable for damages of any kind resulting from errors or omissions in its Event materials, nor shall Sage be liable for any damages resulting from the use of its Event materials or other information conveyed at the Event.
