# **Conference Registration Policies**

#### **Conference registration confirmation policy**

Registration for Sage Sessions Construction and Real Estate Online will be confirmed when full payment is received. If you do not receive a confirmation within forty-eight hours after your completed registration and payment are submitted, please **email** the Sage team and someone will get back to you shortly.

#### Sage U subscription offer

## **Conference cancellation policy**

Conference cancellation requests must be submitted in writing and received on or before midnight ET October 27, 2020 to receive a refund, less a \$25 service and processing fee. Cancellation requests received after midnight ET October 27, 2020, and no-shows are not eligible for a refund. Transfer of the registration fee to subsequent years is not permitted.

Cancellation requests must be submitted in writing and sent to the Sage Sessions team. Cancelling your registration will result in a forfeiture of the 1-year Sage U subscription.

Sage reserves the right to refuse or cancel a registration at any time with no liability other than refunding the applicable registration fee. Registrant must be 21 years of age to register for the conference.

### **Conference substitution policy**

Attendee substitutions from the same company may be made up to one week prior to the event. Transferring registration status to an individual outside your company is not permitted.
