Conference registration confirmation policy

Registration for Sage Sessions Construction and Real Estate Online will be confirmed when full payment is received. Sage U subscription offer

Conference cancellation policy

Conference cancellation requests must be submitted in writing and received on or before midnight ET October 27, 2020 to receive a refund, less a \$25 service and processing fee.
