

# **Conference Registration Policies**

# **Conference confirmation policy**

Registration for Sage Summit US will be confirmed when full payment is received. If you do not receive a confirmation within forty-eight hours after your completed registration and payment are submitted, please email the <a href="Sage Summit US registration team">Sage Summit US registration team</a>.

### **Conference cancellation policy**

Standard conference cancellation requests must be submitted in writing and received on or before midnight ET November 29, 2020 to receive a refund, less a \$25 service and processing fee. Cancellation requests received after midnight ET November 29, 2020 and no-shows are not eligible for a refund. Transfer of the registration fee to subsequent years is not permitted.

Cancellation requests must be submitted in writing and sent to <a>Sage Summit US registration team</a>.

Sage reserves the right to refuse or cancel my registration at any time with no liability other than refunding the applicable registration fee. Registrant must be 21 years of age to register for the Conference.

### Conference substitution policy

Attendee substitutions from the same company may be made up to one week prior to the event. Transferring registration status to an individual outside your company is not permitted. Contact <a href="SageSummitUS@sage.com">SageSummitUS@sage.com</a> to request a substitution or a full cancellation. **Note:** The transfer process is not complete until the new attendee request is submitted, and the new attendee has registered.

### Hotel changes and cancellations policy

Gaylord Palms reservations at the negotiated Sage rate will be made directly through the hotel reservation link on the event website prior to November 16, 2020. After November 16, 2020 reservations will be accepted on an as available basis. Upon completion of a reservation the Gaylord Palms will charge your credit card for one-night deposit room and tax. Room cancellations at the Gaylord Palms can be made up to 72 hours prior to arrival or you will surrender your deposit.

Hilton Bonnet Creek reservations at the negotiated Sage rate will be made directly through the hotel reservation link on the event website prior to November 16, 2020. After November 16, 2020 reservations will be accepted on an as available basis. Upon completion of a reservation the Gaylord Palms will charge your credit card for one-night deposit room and tax. Room cancellations at the Hilton Bonnet Creek can be made up to 5 days prior to arrival or you will surrender your deposit.

#### Notice and release—filming/photography

Badges are to be picked up at the event check-in area during the event. You must show a government issued picture ID to be issued your badge. Badges will not be issued without an ID and you will not be admitted into the venue without a badge. Badges may contain RFID and/or NFC tags, which will be used to record your attendance and participation in the event, sessions and events and to provide you with feedback surveys following the sessions, to review and improve the event, including for safety reasons. If you demonstrate an interest in a partner or topic, such as by visiting a booth or attending a session, Sage may share your registration information with such partner if you allow the partner to scan your badge. Information collected through badges will not be disclosed to third parties, except with partners as set forth in these terms.

### **Personal information**
